Great news! After having an employee test positive two weeks ago, we have completed three rounds of COVID testing on both staff and residents that are all negative. We can now return to visitation as it was prior to the positive test, with the exception of requiring visitors to wear a surgical mask at all times. We ask this since the community spread is increasing from the delta variant. Thank you all for your support and understanding.

As we have done for a while now, Sheri is scheduling all visits. We ask that you call her directly at 906-204-1014 as things are very busy in the reception area and the less calls to our main number the better.

If you are not feeling well or have COVID symptoms, please do not come to the facility and instead visit by a remote method, such as Facetime or telephone.

We continue to closely monitor residents for symptoms. Staff also are being screened before their shift for symptoms.

We strongly encourage everyone to get the vaccine as soon as you can. It is very effective at controlling the spread of the deadly COVID-19 virus.
