We have received guidance that our staff and residents should get a vaccine booster. We are working with Snyders to make this happen as soon as we can.

Because community spread is high, we will continue with our current precautions to protect our residents and staff from getting COVID. At this time, anyone spending time with residents must wear an N95 mask and face shield at all times, both inside and outside. We understand that this is less than ideal but ask for your patience as we navigate through this pandemic. If you choose to ignore our safety precautions, we will have to curtail your visits. With the Holiday Season quickly approaching we are diligently working on recruiting extra staff to help with visitation for Thanksgiving, the Day after Thanksgiving, Christmas Eve and Christmas Day. Unfortunately, meals will not be offered to families again this year.

As a reminder, our visits are tightly scheduled, and we need you to be here on time in order for you to take advantage of the whole time allotted for your visit. Because staff is assigned to each visit, please let us know if you can't make it on time for your visit. Sheri is our designated visit coordinator in the front office. **Please call her directly for scheduling visits at 906-204-1014.**

If you are not feeling well or have COVID symptoms, please do not come to the facility and instead visit by a remote method, such as Facetime or telephone.

We continue to closely monitor residents for symptoms. Staff also are being screened before their shift for symptoms.

We strongly encourage everyone to get the vaccine as soon as you can. It is very effective at controlling the spread of the deadly COVID-19 virus.
