Notice:

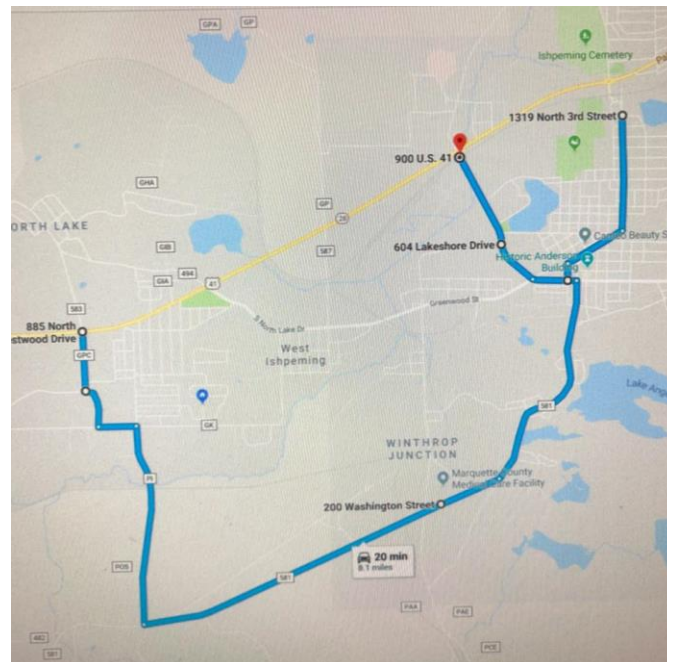
The City of Ishpeming Water Improvement Project will cause a road closure on Washington Street beginning September 4, 2018 through mid-October.

If you normally turn off of US-41/M-28 onto Lakeshore Drive please continue on Lakeshore Drive until you reach the first stop sign at Pine Street where you will need to turn right and follow Pine/Saginaw to our front Parking Lot.

From 3rd Street turn right onto Hematite Dr., take a left on Lake Street, a left on Division and a Right on Pine.

A section of Stoneville Road (PI) will also be closed by the County Road Commission on September 10th. If this is your normal route you will need to turn onto Westwood Drive (GPC) to Southwood Dr.(GK) take a left onto Southwood Drive and then a right onto Stoneville Road to follow your usual route.
