FROM THE ADMINISTRATOR

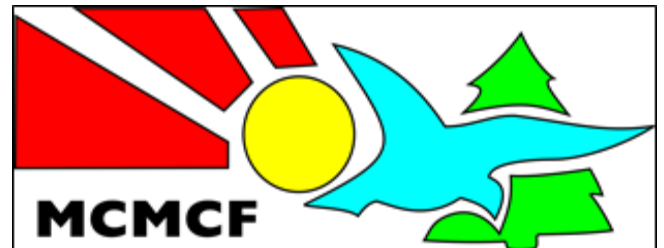
