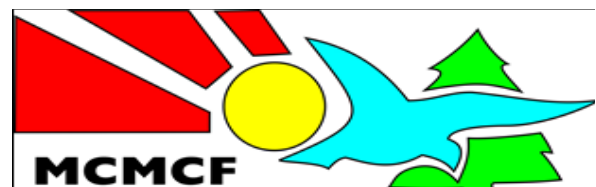
## October Employee of the Month

## Welcome to the October Newsletter

COVID update. Staff testing continues weekly. We have gone over 14 days without a positive test so visits can take place.

Governor Whitmer's Executive Orders have changed to allow all resident's to have outside visits. Visits can be arranged Monday thru Friday by appointment only and are limited to 30 minutes. Visitors must agree, in writing, to wear a mask, observe social distancing, and practice hand hygiene or lose their visitation privileges. All visits will be observed by a staff member that understands these infection control guidelines. Visitors must agree to be screened for temperature and COVID-19 symptoms before every visit. Only two visitors are allowed per resident.

It is understood that it is getting cold and outside visits become less practical as we get later in the Fall. We are hopeful for guidance to come out that will allow safe inside visits for all residents.

Because of the limitations on outside visits, we still encourage you to arrange FaceTime and phone visits by setting up appointments with the Activities department. Window visits are also allowed, but times must be arranged so we have a phone for the resident as the window MUST remain closed.

We continue to monitor residents for symptoms and staff screening prior to their shift. We have tested residents and staff that presented with COVID like symptoms and all have come back negative.

I urge you to follow us on Facebook if you can as we are trying to put up as many pictures of your loved ones as we can so you can see them.
