## April Employee Of the Month

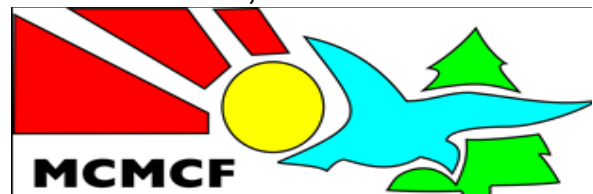
### Mitch Schultz

## Welcome to the April Newsletter From the Administrator

I'm happy to report that indoor visitation continues!.

Our guidance continues to strongly recommend visitors get tested before visiting your loved ones. Hugs are now allowed! The stipulations are: 1) the resident is fully vaccinated (2 weeks from final vaccination) 2) the visitor wears a N95 mask 3) resident wears a mask and 4) proper hand hygiene is completed.

Warning: if any staff or resident has a positive test all visits must be cancelled until outbreak testing is completed. The appearance of the more contagious COVID variant in Marquette County makes us worry and we really need to keep following the COVID safety advice: frequent handwashing, social distancing, and wearing a mask. As the vaccine becomes more readily available, sign up.

Please contact Nick at 906-204-1021 to set up a visit on the 100,200,300 or 400 wings. Contact Mischelle at 906-204-1017 for 500 and 600 wing visits. If you are being tested, call the main desk (if you have a cell phone) when you arrive. You may park in the loop by the main door and someone will come out to your car and perform the COVID test. You can then park and we will notify you when your test result is available. We are leaving the rows closest to the door reserved for visitor's parking for your convenience. PLEASE be on time as the visits are tightly scheduled and being late disrupts the schedule.

Rules for visits: Visitor(s) entering the building must have their temperature taken and complete a symptom questionnaire prior to visit. There is a 30-minute time limit. Visits are limited to Monday thru Friday due to staffing and reporting requirements. Two visitors maximum are allowed at a time. You must be at least 14 years old. Visits are staff supervised. A mask must be worn. 6 feet distance must be maintained between resident and visitor (except for during hugs).

Visitors will be educated on these rules and agree by signature to abide by them.

The 700 wing is used for isolation of new admits for 14 days and symptomatic residents. Unfortunately, this means no inside visitation for residents on the 700 wing except for end-of-life visits.

If unable to have an indoor visit, we encourage you to visit your loved ones by arranging FaceTime and phone visits by setting up appointments with the Activities department. Window visits are also allowed, but times must be arranged so we have a phone for the resident as the window MUST remain closed.

We continue to closely monitor residents for symptoms. Staff also are being screened before their shift for symptoms.
